OBJECT: On registration of "The Albanian Democrat Union Party" as electoral subject for local government elections of June 30, 2019

LEGAL REFERENCE: Article 23, item 1, letter "a", article 64 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended.

29.12.2008, The Electoral Code of the Republic of Albania" as amended, with the Decree no.10928, dated 05.11.2018 set June 30, 2019, as the date of local government elections.

The Albanian Democrat Union Party, with initials "PBD" represented by its chairman, Mr. Ylber Valteri, submitted to the CEC the request with prot.no. 2254, dated 09.04.2019 and the respective documentation in order to be registered as electoral subject for local government elections to be held on June 30, 2019.

The request submitted by the Albanian Democrat Union Party meets the deadline stipulated in item 1, article 64 of the Electoral Code, as amended.

After reviewing the documentation attached to the request, the CEC found that it is in full compliance, in terms of the form and content, with the item 2, article 64 of the Electoral Code, as amended.

Specifically, it has submitted:

- The certificate issued by the Registration Office of Political Parties, in Tirana District Court, dated 05.04.2019, through which it is certified that the Albanian Democrat Union Party, with the initials PBD and chaired by Mr. Ylber Valteri, is registered in this Office;
- first, last name and the address of the chairman of the party;
- official name, initials and the address of the party ;
- specimen of the seal of the party;
- first, last name and the address of the finance officer of the party (Mr.Elez Delia)
- first, last name and the address of the person responsible for the communication with the CEC (Mr. Miftar Myrtja);

The Central Elections Commission, after making the respective checks, and after finding that the request and the documentation submitted by the Albanian Democrat Union Party are in compliance with the criteria defined in article 64 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended,

DECIDED:

1. To register the Albanian Democrat Union Party, with initials "PBD", chaired by Mr.Ylber Valteri as electoral subject for loal government elections of June 30, 2019.
