## NOTES

The President of the Republic, pursuant to article 92, letter "gj" and article 93 of the Constitution of the Republic of Albania and article 9, paragraph 1 of the law no.10019, dated 29.12.2008, "The Electoral Code of the Republic of Albania" as amended, with the Decree no.10928, dated 05.11.2018 set June 30, 2019, as the date of local government elections.

The Communist Party of Albania, with initials "PKSH" represented by its chairman Mr.Qemal Cicollari, submitted to the CEC the request with prot.no. 2269, dated 09.04.2019 and the respective documentation to be registered as electoral subject for local government elections to be held on June 30, 2019.

The request submitted by the Communist Party of Albania is within the deadline stipulated in item 1, article 64 of the Electoral Code, as amended.

Based on the analysis of the documentation attached to the request, the CEC found that it is in full compliance, in terms of the form and content, with the item 2, article 64 of the Electoral Code, as amended.

Specifically, it has submitted:

-The certificate issued by the Registration Office of Political Parties, in Tirana District Court, dated 05.04.2019, through which it is certified that the Communist Party of Albania, with the initials PKSH and chaired by Mr. Qemal Cicollari, is registered in this

Office;

- first, last name and the address of the chairman of the party;
- official name, initials and the address of the party ;
- specimen of the seal of the party;
- first, last name and the address of the finance officer of the party (Mr.Shahin Çaçà)
- first, last name and the address of the person responsible for the communication with the CEC (Mr.Xhemal Shehu);

The Central Elections Commission, after making the respective checks, and after finding that the request and the documentation submitted by the Communist Party of Albania are in compliance with the criteria defined in article 64 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended,
