**ON APPOINTMENT OF SECRETARIES IN SOME COMMISSIONS OF ELECTIONS
ADMINISTRATION ZONES (CEAZ) FOR LOCAL GOVERNMENT ELECTIONS OF JUNE 30, 2019**

OBJECT On appointment of some secretaries of CEAZs for June 30, 2019 local government elections

LEGAL REFERENCE: Article 23, item 1, letter “a”, article 28, item 1, article 29, item 5, article 30, article 31 of the Electoral Code of the Republic of Albania

The CEC, after reviewing the submitted documentation and heard the discussions of those present,

NOTES

The Central Elections Commissions, with its Decision no. 141, dated 09.04.2019, filled the vacancies in CEAZs by appointing members in the CEAZs with an odd number and secretaries in the CEAZs with an even number, among the list of the citizens that were adopted by the CEC Decision no. 140, dated 09.04.2019, who were eligible for appointment as members and secretaries of the CEAZ for local government elections of June 30, 2019.

In the CEAZs no. 22 and no. 24 (Commissions of Election Administration Zones in Durrës municipality), CEAZ no. 60 (Roskovec Municipality), CEAZ 80 (Dropull Municipality), CEAZ no. 86 (Himara

Municipality), the vacancies created for the position of the CEAZ Secretary, were not filled, because the citizens listed in the list approved by the CEC, residents of these elections zones, did not have a diploma in law. In reply to the public call, announced in the meeting held on 09.04.2019, the following citizens submitted applications, along with the documentation, to fill the vacant position of the CEAZ secretary

2. Teodor Iljaz Labi, inhabitant of Durrës municipality;
3. Daniela Petrit Rexho, inhabitant of Durrës municipality (Njësia Administrative Sukth);
4. Evisa Sami Gishto (Mustafaj), inhabitant of Roskovec municipality;
5. Pirro Thanas Boboli, inhabitant of Dropull municipality;
6. Nurjet Jani Mici, inhabitant of Himarë municipality.

After the review of the documentation and verification of the data, the following citizens meet the criteria defined in article 30 and 31 stipulated in the Electoral Code, for filling in the vacancies that were created:

The national Elga Nikolla Gogo, Daniela Petrit Rexho and Teodor Iljaz Labi, to be appointed to fill the vacancy of the secretary of the CEAZ no.22 and 24.

The national Evisa Sami Gishto, to be appointed to fill the vacancy of the secretary of the CEAZ no.60, Roskovec Municipality;

The national Pirro Thanas Boboli, to be appointed to fill the vacancy of the secretary of the CEAZ 80, Bashkia Dropull;

The national Nurjet Jani Mici, to be appointed to fill the vacancy of the secretary of the CEAZ 86, Bashkia Himarë.

The vacancies in the CEAZ no. 22, 24, 60, 80, 86, were filled according to Instruction no. 4, date 19.02.2013 "On procedures of selection and training of the nationals eligible to be appointed by the CEC to fill the vacancy created in the CEAZ and VCC", as amended.

FOR THESE REASONS

The Central Elections Commissions, based on article 23, item 1, letter "a", article 28, item 1, article 29, item 5, article 30, article 31, of the Electoral Code of the Republic of Albania,

DECIDED:

1. To adopt the list of the nationals eligible to be appointed by the CEC to fill the vacancy in CEAZ according to the Link no.1 attached.
2. To appoint in the position of the secretary of the CEAZ no. 22, 24, 60, 80, 86, the nationals according to the Link no. 2 attached.

3. The first meeting of the Commission of Election Administration Zones no.22, 24, 60, 70, 80, 86, will be held on Thursday, on April 18, 2019, at 10.00 in CEAZ Headquarters.

4. This Decision comes immediately into effect.

5. This decision can be appealed in the Electoral College in Tirana Court of Appeals, within 5 days from its publication.
