Examine the case :

OBJECT: For registration as electoral subject " Liberal Democratic Union Party" the elections for local government bodies of 30 June 2019.

LEGAL BASIS : Article 23, point 1, letter "a", article 64, of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania",

The Central Election Commission after reviewing the submitted documentation and listening to the discussions of representatives of political parties.

Notes:

The President of the Republic of Albania, , in support of article 92, letter "gj" and Article 93 of the Constitution of the Republic of Albania. as well as Article 9, paragraph 1, of Law no. 10019, dated 29.12.2008 The "Electoral Code of the Republic of Albania" changed by decree no. 10928 dated 05.11.2018 has appointed the date of 30 June 2019 for the conduct of elections for the local government bodies.

The Liberal Democratic Union Party, with letter "BLD", through its President, Mr. Arjan Starova, submitted to the Central Election Commission the request and the relevant documentation to be registered as an electoral subject for elections for local government bodies to be held on June 30, 2019, administered with no. 1612 prot., dated 27.03.2019.

The request submitted by the "Liberal Democratic Union Party" respects the time limit provided for in paragraph 1 of Article 64 of the Electoral Code, as changed.

From the analysis of the submitted documentation attached to the request, it is evidenced the full respect, in the form and content, of the requirements of point 2 of article 64 of the Electoral Code, as changed.

Specifically, is presented:

- Certification released by the Political Party Registry Office, Tirana District Court, dated 26 March 2019, confirming that the "Liberal Democratic Union Party", with initials "BLD", and w Chairman Mr. Arian Starova, results registered in the documentation of this Office;

- name, surname and address of party chairman;

- official name, letter heads and party address;

- the specimen of the party stamp;

- name, surname and address of the party financier (Mr. Kimete Rama);

- name, surname and address of the person responsible for communication with the CEC (Mr. Ahaqir Rexhvelaj);

The Central Election Commission, following the respective verifications and notices that the request and the documentation submitted by the "Liberal Democratic Union Party" are in accordance with the criteria of Article 64 of Law No. 10019, dated 29.12.2008 "Electoral Code Republic of Albania ", as changed.

Decision:

1. To register the "Liberal Democratic Union Party", with the chairman, Arian Starova, and with letterheads "PBLD", as the electoral subject for the elections for the local government bodies of 30 June 2019.

2. This decision shall enter in force immediately.

3. An appeal may be appealed against the decision in the Electoral College at the Tirana Court of Appeal within 5 days of its announcement.
