Examine the case :

OBJECT: To register candidate for mayor of Elbasan. Gledian Iljaz Llatja, proposed by the coalition "Alliance for European Albania "for elections to the 2019 local government bodies.

LEGAL REFERENCE : Article 23, point 1, letter "a", article 67, point 2, article 165, paragraph 3 article 72 and article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania

The Central Election Commission after reviewing the documentation submitted by the coalition "Alliance for European Albania" and hearing the discussions of representatives of political parties,

Notes:

With the decision of the CEC No.251 dated 07.05.2019, the Coalition "Alliance for European Albania" was registered as an electoral subject for elections to local government bodies of June 30, 2019. Under the Coalition "Alliance for European Albania" agreement, For the registration of the candidate for mayor of Elbasan, proposed by the coalition "Alliance for European Albania" Gledian Iljaz Llatja for the elections for the local government bodies of 2019.

Chairman of the Socialist Party of Albania, Edi Rama will be the person who will authorize the responsible persons to sign on behalf of the coalition the request for registration of candidates for mayor.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania" has deposited with the CEC the application for registration of Mr. Gledian Iljaz Llatja as a candidate for Mayor of Elbasan.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or council of Shkodra Municipality, since the Municipality of Shkodra is administered by more than one CEAZ. Allocated the application is filed and the relevant documentation, as listed below:

1. Request for registration of Mr. Gledian Iljaz Llatja as candidate for Mayor of Elbasan;
2. Declarations of the candidate declaring that he enjoys the right and will to run for Mayor in the Municipality of Elbasan, proposed by the Coalition "Alliance for European Albania" in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, confirming that the Socialist Party is represented by 74 members of the Assembly of the Republic of Albania.
4. Copy of the ID card of Mr. Gledian Iljaz Llatja, according to which it turns out that Mr. Gledian Iljaz Llatja is residing in the Municipality of Elbasan;
5. Graphic design Mr. Gledian Iljaz Llatja as candidate for Mayor of Elbasan;
6. The self-charter form, pursuant to law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".
7. Official record of filing of the candidacy documents..

In implementation of law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", verified the data on the self-declaration forms for the candidate for mayor. The CEC has also published the self-declaration form on the official website.

By verifying the data declared in the self-declaration form and information received from the General Directorate of Prisons Mr. Gledian Iljaz Llatja, is not under the terms of Article 2 of Law no. 138/2015, for his rejection as a candidate for mayor, proposed by the Coalition "Alliance for European Albania".

The Central Election Commission, based on article 73, point 1 of the Electoral Code, in its meeting of 15.05.2019, verified the candidacy documentation for the chairman, Gledian Iljaz Llatja, in the Municipality of Elbasan, deposited by the Coalition "Alliance for European Albania" and found that it was in compliance with the requirements set forth in Article 67, paragraph 2, Article 165, Article 72 and Article 73 of the Electoral Code.

For the registration of the candidate for mayor of Elbasan, proposed by the coalition "Alliance for European Albania" Gledian Iljaz Llatja for the elections for the local government bodies of 2019.

FOR THESE REASONS:

The Central Election Commission based on article 23, point 1, letter "a", article 67, points 2, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 " Electoral Code of the Republic of Albania ".

DECIDED:

1. To register as mayor candidate in the Municipality of Elbasan for elections to the local government bodies of 30 June 2019, Gledian Iljaz Llatja proposed by the Coalition "Alliance for European Albania".
2. This decision shall enter into force immediately.
3. An appeal may be filed against the decision in the Electoral College at the Tirana Court of Appeal within 5 days of its announcement.
