"ALLIANCE FOR EUROPEAN ALBANIA" Mr. RAKIP BAJRAM SULI FOR ELECTIONS
FOR LOCAL GOVERNMENT BODIES DATED 30 JUNE 2019**

OBJECT: For the registration of candidate for mayor of Kamza, Rakip Bajram Suli proposed by the coalition "Alliance for European Albania", for elections to local government bodies on 30 June 2019.

LEGAL REFERENCE: Article 23, point 1, letter "a", article 67, point 2, article 165, point 3 article 72 and article 73 point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania "

The Central Election Commission after reviewing the documentation submitted by the coalition "Alliance for European Albania" and hearing the discussions of representatives of political parties,

NOTICED:

With the decision of the CEC No.251 dated 07.05.2019, the Coalition "Alliance for European Albania" was registered as an electoral subject for elections to local government bodies of June 30, 2019. Under the Coalition "Alliance for European Albania" agreement, the chairman of the Socialist Party of Albania, Mr. Edi Rama will be the person who will authorize the responsible persons to sign on behalf of the coalition the request for registration of candidates for mayor.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania" has deposited in the CEC a request for the registration of Mr. Rakip Bajram Suli as candidate for mayor of Kamza.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or council of Kamza municipality, since the Municipality of Kamza is administered by more than one CEAZ.

Attached this application is filed and the relevant documentation, as listed below:

1. Request for registration of Mr. Rakip Bajram Suli as candidate for mayor of Kamza;
2. Declarations of the candidate declaring that he enjoys the right and will to run for Mayor in Kamza Municipality, proposed by the Coalition "Alliance for European Albania" in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, according to which it is proved that the Socialist Party is represented by 74 members of the Assembly of the Republic of Albania.
4. Copy of the ID card of Mr. Rakip Bajram Suli, according to which it results that Mr. Rakip Bajram Suli is settled in the Municipality of Kamza;
5. The biography of Mr. Rakip Bajram Suli as candidate for mayor of Kamza;
6. The self-charter form, pursuant to law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".
7. Official record of filing of the candidacy documents..

In implementation of law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", verified the data on the self-declaration forms for the candidate for mayor. The CEC has also published the self-declaration form on the official website.

By verifying the data declared in the self-declaration form and information received from the General Directorate of Mr. Rakip Bajram Suli is not under Article 2 of Law No.138 / 2015, for his rejection as a candidate for mayor, proposed by the Coalition "Alliance for European Albania".

The Central Election Commission, based on article 73, point 1 of the Electoral Code, in its meeting of 15.05.2019, verified the candidacy documentation for the chairman, Rakip Bajram Suli in Kamza Municipality, deposited by the Coalition "Alliance for European Albania" and found that it was in compliance with the requirements set forth in article 67, paragraph 2, article 165, article 72 and article 73 of the Electoral Code.

FOR THESE REASONS:

The Central Election Commission based on article 23, point 1, letter a, article 67, points 2, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania ".

DECIDED:

1. Register as candidate for mayor in the Municipality of Kamza for elections to local government bodies of June 30, 2019, Mr.Rakip Bajram Suli proposed by the Coalition "Alliance for European Albania".
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
