**FOR THE REGISTRATION OF THE CANDIDATE FOR MAYOR OF VLORA MUNICIPAL PROPOSED BY THE COALITION "ALLIANCE FOR EUROPEAN ALBANIA" Mr. DRITAN HALIL LELI FOR ELECTIONS FOR THE LOCAL GOVERNMENTS OF DATED 30 JUNE 2019**

**OBJECT:** For the registration of the candidate for mayor of Vlora, Dritan Halil Leli, proposed by the coalition "Alliance for European Albania", for the elections for the local government bodies of the year 2019.

**LEGAL REFERENCE :** Article 23, point 1, letter a, article 67, paragraph 2, article 165, point 3 article 72 and article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

The Central Election Commission after reviewing the documentation submitted by the coalition "Alliance for European Albania" and hearing the discussions of representatives of political parties,

The Central Election Commission in its meeting of 15.05.2019, with the participation of:

**Noticed:**

With the decision of the CEC No.251 dated 07.05.2019, the Coalition "Alliance for European Albania" was registered as an electoral subject for elections to local government bodies of June 30, 2019. Under the Coalition "Alliance for European Albania" agreement,

Chairman of the Socialist Party of Albania, Edi Rama will be the person who will authorize the responsible persons to sign on behalf of the coalition the request for registration of candidates for mayor.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania" has deposited in CEC a request for the registration of Mr. Dritan Halil Leli as candidate for mayor VLORË.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or council of Vlora Municipality, since the Municipality of Vlora is administered by more than one CEAZ. Allocated the application is filed and the relevant documentation, as listed below:

1. Request for registration of Mr. Dritan Halil Leli as mayoral candidate in Vlora;
2. Declarations of the candidate declaring that he enjoys the right and will to run for mayor in the Municipality of Vlora, proposed by the Coalition "Alliance for European Albania" in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, according to which it is proved that the Socialist Party is represented by 74 members of the Assembly of the Republic of Albania.
4. Copy of the ID card of Mr. Dritan Halil Leli, according to which it turns out that Mr. Dritan Halil Leli is settled in the Municipality of Vlora;
5. The biography of Mr. Dritan Halil Leli as mayoral candidate in Vlora;
6. The self-decree form, pursuant to Law 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".
7. Official record of filing of the candidacy documents.

In implementing Law 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", verified the data on the self-declaration forms for the candidate for mayor. The CEC has also published the self-declaration form on the official website.

By verifying the data declared in the self-declaration form and information received from the General Directorate of Mr. Dritan Halil Leli is not in the terms of Article 2 of Law no. 138/2015, for his rejection as a candidate for mayor, proposed by the Coalition "Alliance for European Albania".

The Central Election Commission, based on article 73, point 1 of the Electoral Code, in its meeting of 15.05.2019, verified the candidacy documentation for the chairman, Dritan Halil Leli in the Municipality of Vlorë, deposited by the Coalition "Alliance for European Albania" and found that it was in accordance with the requirements set forth in Article 67, paragraph 2, Article 165, Article 72 and Article 73 of the Electoral Code.

**FOR THESE REASONS:**

The Central Election Commission based on Article 23, paragraph 1, letter "a", article 67, points 2, 4, 5, and 6, Article 72, and Article 73, paragraph 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code Republic of Albania ".

**NOTICED :**

1. To register as mayor candidate in the Municipality of Vlora for elections to local government bodies of 30 June 2019, Dritan Halil Leli proposed by Coalition "Alliance for European Albania".
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
