PROPOSED BY THE COALITION "ALLIANCE FOR EUROPEAN ALBANIA" MR. PJERIN ZEF  
AGREED TO THE ELECTIONS TO THE LOCAL GOVERNMENT BODIES OF 30 JUNE 2019**

**OBJECT:** For the registration of the candidate for mayor of Lezha Municipality, Pjerin Zef Ndreu, proposed by the coalition "Alliance for European Albania", for the elections for local government bodies of the date 30 June 2019.

**LEGAL REFERENCE:** Article 23, point 1, letter a, article 67, point 2, article 165, paragraph 3 article 72 and article 73, point 1 of law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania"

The Central Election Commission after reviewing the documentation submitted by the coalition "Alliance for European Albania" and hearing the discussions of representatives of political parties,

**NOTES:**

With the decision of the CEC No.251 dated 07.05.2019, the Coalition "Alliance for European Albania" was registered as an electoral subject for elections to local government bodies of June 30, 2019. According to the agreement of the Coalition "Alliance for European Albania", the chairman of the Socialist Party of Albania, Edi Rama will be the person who will authorize persons responsible for signing on behalf of the coalition the application for registration of candidates for Mayor.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania"

has deposited at CEC a request for the registration of Mr. Pjerin Zef Ndreu as candidate for mayor of Lezha.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or for the Lezha Municipal Council, since the Municipality of Lezha is administered by more than one CEAZ.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania" has deposited at CEC a request for the registration of Mr. Pjerin Zef Ndreu as candidate for mayor of Lezha.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or for the Lezha Municipal Council, since the Municipality of Lezha is administered by more than one CEAZ.

The attached application is filed and the relevant documentation, as listed below:

1. Request for registration of Mr. Pjerin Zef Ndreu as Mayor of Lezha.
2. Declarations of the candidate declaring that he/she enjoys the right and will run for mayor in the Municipality of Lezha, proposed by the Coalition "Alliance for European Albania" in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, confirming that the Socialist Party is represented by 74 members of the Assembly of the Republic of Albania.
4. Copy of the Identity Card of Mr. Pjerin Zef Ndreu, according to which it turns out that Mr. Pjerin Zef Ndreu is residing in the Municipality of Lezha;
5. Life Style Mr. Pjerin Zef Ndreu as mayor of Lezha.
6. The self-declaration form, pursuant to law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".
7. Minutes of submission of the candidacy documents.

In implementation of law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", verified the data on the self-declaration forms for the candidate for mayor. The CEC has also published the self-declaration form on the official website.

By verifying the self-declaration form, it results Mr. Pjerin Zef Ndreu, stated in point 4 that he was detained or arrested by law enforcement authorities for committing a criminal offense "for malicious use of telephone calls". In point 5, the restrictive personal security measure "obligation to appear in the judicial police" has been stated. The Court of the Tirana Judicial District, for the criminal offense provided for by Article 275 of the Criminal Code, has sentenced innocent.

The judicial office has sent to the Central Election Commission, verifying the judicial situation, which results that Mr. Pjerin Zef Ndreu is unpunished by Albanian courts.

The Central Election Commission, referred to point 2, last paragraph, of Chapter V of Decision no. 17/2016 of the Assembly ascertains that the declared data do not constitute a condition for non-registration as a candidate under Law no. 138/2015. Also, the CEC has made the publication of the declaration forms on the official website.

The Central Election Commission, based on Article 73, paragraph 1, of the Electoral Code, in its meeting of 15.05.2019, verified the candidacy documentation of Mr. Pjerin Zef Ndreu as candidate for mayor of Lezha, deposited by Coalition "Alliance for European Albania" and found that it was in accordance with the requirements set forth in article 67, paragraph 2, article 165 article 72 and Article 73 of the Electoral Code.

**FOR THESE REASONS:**

The Central Election Commission based on Article 23, paragraph 1, letter "a", article 67, points 2, 4, 5 and 6, Article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code Republic of Albania "

**DECIDED:**

- 1 To register as mayor candidate in Lezha Municipality for elections to local government bodies of 30 June 2019, Pjerin Zef Ndreu, proposed by the Coalition "Alliance for European Albania".
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
