FOR THE REWIEVING OF THE REQUEST FROM THE NATIONAL CONSERVATIVE PARTY OF ALBANIA FOR SUBMITTING DOCUMENTS FOR THE CANDIDATE REGISTRATION FOR THE MUNICIPALITY AND THE MULTINAME LIST OF CANDIDATES FOR MEMBERS AT THE COUNCIL OF MUNICIPALITIES FOR ELECTIONS TO THE LOCAL GOVERNMENTS OF THE DATE 30 JUNE 2019

**OBJECT:** To review the request of the National Conservative Party Albania for the submission of documents for the registration of candidates for mayor and the multi-name list of candidates for members of the Municipal Council for elections to local government bodies of 30 June 2019.

#### NOTES:

Party "National Conservative Albania" with the decision of the CEC no. 40, dated March 13, 2019, has been registered as an electoral subject for elections for local government bodies in 2019.

Pursuant to Article 67, paragraph 1, the Electoral Code of the Republic of Albania provides that "The political party that has been registered with the CEC as an electoral subject for elections submits to the CEC the multi-name list of its candidates for each electoral zone no later than 50 days before the election date. For local government elections, the candidate for mayor of the local government unit and the list of candidates for local councils are registered with the CEAZ that covers the local government unit within the time limit set out in this point. The CEAZ submits a copy of the list to the CEC within 48 hours.

# FOR THESE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter a, Article 67, paragraph 1 of law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", as amended.

## **DECIDED:**

1. The refusal of the National Conservative Party Albania's application for the submission of documents for the registration of candidates for mayor and the multi-name list of candidates for members of the Municipal Council for elections to local government bodies dated 30 June 2019.

2. This decision shall enter into force immediately.

3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
