**OBJECT:** To approve the accreditation of long-term observers submitted by KRIIK for election observation for local government bodies of 30 June 2019.

**LEGAL REFERENCE :** Article 23, paragraph 1, letter "a", article 6, point 2, 4, 5 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", amended and Instruction no. 13, dated 22.04.2009 "On Accreditation Procedures and Rules of Election Observation by Albanian and Foreign Non-Governmental Organizations, International Organizations, Representatives of Foreign Countries and the Media"

**NOTICE :**

The Coalition for Reform, Integration and Consolidated Institutions (KRIIK Albania) is an organization which has as its mission the protection and guarantee of human rights and freedoms and the full dimension of human security through the strengthening of the rule of law, democratic governance, promotion of civic engagement and engagement, and promotion of accountability, transparency and full accountability of public and political institutions. This organization has submitted its request with no. prot. 4338, dated 23.05.2019, along with supporting documentation to the CEC for the accreditation of 11 (eleven) long-term observers. From reviewing the documentation, the Central Election Commission notes that it is within the terms and conditions provided by the Electoral Code.

**FOR THESE REASONS :**

Pursuant to Article 23, paragraph 1, letter "a", Article 6, paragraph 2, section 4.5 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", as amended, and Instruction no.13, dated 22.04.2009 "On accreditation procedures and rules of election observation by Albanian and foreign non-governmental organizations, international organizations representing foreign countries and the media ", the Central Commission of election:

**DECIDED :**

1. To approve KRIIK Albania's request for the accreditation of 11 (eleven) long-term observers for observing the election process for local government elections of June 30, 2019, according to the list set forth in link No.1 attached to this decision.
2. This decision shall enter into force immediately.
3. An appeal against this decision can be made at the Electoral College, at the Court of Appeal in Tirana, within 5 days of its announcement.
