FOR VERIFICATION OF SELF DECLARATIONS FORMS ON THE CANDIDATE SELECTION FROM THE MULTINAME LIST FOR MAYOR FROM THE PARTY BINDJA DEMOKRATIKE IN IMPLEMENTING LAW NO. 138/2015 "ON THE GUARANTEE OF THE PERSONAL INTEGRITY THROUGH, EXERCISEING OR USE PUBLIC FUNCTIONS", FOR THE ELECTIONS TO THE LOCAL GOVERNMENTS BODIES OF THE DATE 30JUNE 2019

OBJECT: For the verification of self declarations forms on the candidate selection from the multiname-list for the mayor from the party "BINDJA DEMOKTRATIKE " in implementing law no.138/2015 " On the guarantee of personal integrity throught, exerciseing or use public functions ", for the elections to local governments bodies of the date 30 june 2019

LEGAL REFERENCE : Article 23, point 1, letter "a", of Law no. 10019, dated 29.12.2008 "Code Election of the Republic of Albania, as amended. The Central Election Commission after reviewing the submitted documentation and listening to the discussions of the attendees,

NOTES:

The Bindja Demokratike Party, in accordance with Article 5, paragraph 4, letter "a" of Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", has filed in the Central Election Commission the self-declaration forms of candidates for mayor Cërrik, Kolonjë, Kurbin, Debar, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavaja as the competent body for the administration, verification, implementation of the prohibition of election and appointment in the public office, including the function of the councilor of the municipality.

Pursuant to the law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", the CEC has verified the data in the self-declaration forms for each multi-name list candidate. law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

By verifying the self-declaration forms of mayor candidates for these municipalities: Cërrik, Kolonjë, Kurbin, Dibër, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavajë none of them has stated any data related to projections for prohibitions in law no.138/2015, "On guaranteeing the integrity of persons elected, appointed or exercised public functions ".

The Central Election Commission pursuant to the law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions" and Chapter V, point 2, letter "b" and point 3, letter "c" of Assembly decision no. 17/2016 "On the establishment of detailed rules on the implementation of the prohibitions provided by law no. 138/2015 ", has requested information from the courtroom office and the civil registry office through the documents as well via email for candidates for mayor, who have submitted the forms self-declaration at the Central Election Commission.

a. The judicial office has sent to the Central Election Commission, the verification of the judicial status for the candidates for mayor, for the municipalities of Cërrik, Kolonjë, Kurbin, Dibër, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavaja. Albanian courts.

Referring to Law no. 138/2015 "On guaranteeing the integrity of the persons elected, appointed or exercising public functions" and point 5/1, 6 of the article 9 of the instruction no.2, dated 29.01.2013 "On setting the rules for depositing and verification of documentation and the deadlines for the publication of the candidates' lists, the CEAZs

should continue the procedures for the registration for Mayor of the municipalities of Cërrik, Kolonjë, Kurbin, Dibër, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavaja of the Democratic local government bodies of 30 June 2019. CEAZs should continue procedures for the registration of mayors of Këlcyrë, Cerrik, Kolonjë, Kurbin, Debar, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavaja.

FOR THESE REASONS:

The Central Election Commission, based on Article 23, paragraph 1, letter "a", of law no. 10019 dated 29.12.2008 "Electoral Code of the Republic of Albania", as amended; Article 5, point 4, letter "f" of Law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions"; Chapter V, of Assembly Decision no. 17/2016 "On the establishment of detailed rules on the implementation of the prohibitions provided by law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

DECIDED:

1. Notification of respective CEAZs for the continuation of procedures for the registration of candidates for mayoral communes of municipalities: Cërrik, Kolonjë, Kurbin, Dibër, Malësi e Madhe, Gramsh, Selenica, Shijak, Kavaja Democratic Opposition Party for Elections for Governance Bodies local government of June 30, 2019.

2. This decision shall enter into force immediately.
