**OBJECT:** On the registration of the candidate for the mayor of Lezhë municipality proposed by the party "Bindja Demokratike" Mr. Salvador Kaçaj on elections for local government bodies dated 30 June 2019.

**LEGAL REFERENCE:** Article 23, point 1, letter "a", article 67, point 2, article 165, point 3 article 72 and article 73 point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

The Central Election Commission, after reviewing the documentation submitted by the party "Bindja Demokratike" and hearing the discussions of representatives of political parties,

**NOTES :**

By the CEC decision no. 230, date 24.04.2019, the party "Democratic Obedience" was registered as an electoral subject for elections to local government bodies on 30 June 2019.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", the party "Bindja Demokratike" has submitted to in the CEC their request for registration of Mr. Salvador Kaçaj as candidate for mayor of Lezhë municipality .

By the CEC decision no. 230, date 24.04.2019, the party " Bindja Demokratike" was registered as an electoral subject for elections to local government bodies on 30 June 2019.

On the registration of the candidate for the mayor Lezhë municipality proposed by the party "Bindja Demokratike", Mr. Salvador Kaçaj on local elections dated 30 June 2019.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", the party " Bindja Demokratike " has submitted to the CEC their request for registration of Mr. Mr. Salvador Kaçaj as candidate for mayor of Lezhë.

Pursuant to Article 67, paragraph 3, the CEC shall register candidates for mayor or for the Lezhë municipal council, since Lezhë Municipality is administered by more than one CEAZ.

The attached request and the relevant documentation are submitted to the CEC as listed below:

1. Request for registration of Mr. Salvador Kaçaj as candidate for mayor of of Lezhë municipality;
2. Declarations of the candidate declaring that he has the right and will to run for mayor in the Municipality of Lezhë, proposed by Bindja Demokratike in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 13 prot., Dated 13.05.2019, which states that "Mr. Andi Përmeti, is a deputy of the Albanian Parliament, announced by decision no. 179, dated 18.04.2019 of the Central Election Commission and sworn in the Assembly on 25.04.2019. He holds the mandate of the MP for at least the last 6 months, according to the provisions of the Electoral Code. In his declaration to the Assembly, according to article 15 of the Rules of Procedure of the Assembly, it results that the MP, Andi Përmeti is declared "independent" and represents the subject " Bindja Demokratike ";
4. Certificate of the Assembly of Albania, no. 13 prot., Dated 13.05.2019, which states that "Mr. Lefter Koka is a deputy of the Albanian Parliament, announced by decision no. 555 dated 26.07.2017 of the Central Election Commission and sworn in the Assembly on 09.09.2017 holds the mandate of the deputy at least 6 months, according to the provisions of the Electoral Code ";
5. Copy of the ID card of Mr. Salvador Kaçaj
6. CV of Mr. Salvador Kaçaj , as candidate for mayor of Lezhë Municipality;
7. The Self-Declaration Form, pursuant to Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

Pursuant to law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", verified the data on the self-declaration forms for the candidate for mayor. The CEC has also published the self-declaration form on its official website.

By verifying the data declared in the self-declaration form and information received from the General Directorate of Prisons, Mr. Salvador Kaçaj is not in the terms of Article 2 of Law no. 138/2015, for refusing her as a candidate for mayor, proposed by the party " Bindja Demokratike " .

On the registration of the candidate for the mayor Lezhë municipality proposed by the party "Bindja Demokratike", Mr. Salvador Kaçaj on local elections dated 30 June 2019.

The Central Election Commission, based on Article 73, item 1 of the Electoral Code, in its meeting of the 20.05.2019, verified the candidacy for Mayor, Salvador Kaçaj , in the Lezhë Municipality, submitted by the Democratic Opposition Party and found that it was in compliance with the requirements set forth in Article 67, paragraph 2, Article 165, Article 72 and Article 73 of the Electoral Code.

**FOR THESE REASONS:**

The Central Election Commission based on article 23, point 1, letter "a", article 67, points 2, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 " Electoral Code of the Republic of Albania ".

**DECIDED:**

1. To register Mr. Salvador Kaçaj as a candidate for Mayor of Lezhë Municipality for the elections for local government bodies of 30 June 2019, proposed by the Party " Bindja Demokratike "
2. This decision comes into effect immediately
3. An appeal can be filed against this decision in the Electoral College of Tirana Court of Appeals, within 5 days from its publication.
