FOR RETURN TO THE COMPLETE THE MULTINAME LIST OF CANDIDATES FOR MEMBERS IN THE SHKODRA MUNICIPAL COUNCIL, DEPOSITED BY THE PARTY "DEMOCRACY SOCIALE" FOR ELECTIONS FOR THE LOCAL GOVERNMENT BODIES OF 30 JUNE 2019

OBJECT: To return for completion of the multi-name list of candidates for a member of the Shkodra Municipal Council, submitted by the Social Democracy Party, for elections to the local government bodies of 30 June 2019.

LEGAL REMARKS: Article 23, point 1, letter a, article 67, article 72 and article 73, paragraph 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

NOTES:

The "Social Democracy" party has been registered as an electoral subject for elections to the organs local government of June 30, 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" amended, the "Social Democracy" party has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the municipal council of the Social Democracy Party and the accompanying documentation submitted and found the shortcomings of the documentation as follows :

1. Gender quota is not respected in the multi-name list Model 10 K;
2. Declaration for countries by gender quota Model 09 K;
3. The candidate identification document for members of the municipal council, with ordinal number from 1 to ordinal number 21.

Under these conditions CEC should:

To return the candidacy documentation for correcting the deficiencies found by the Social Democracy Party.

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for completing the documentation for the registration of the multi-name list of candidates for the members of the Council of the Municipality of Shkodra, of the Social Democracy Party, for the elections for the local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
