OBJECT: To return for complete the multi-name list of candidates for member of the Kamza Council, presented by the Democratic Alliance Party, for elections to local government bodies of 30 June 2019.

LEGAL REFERENCE: Article 23, point 1, letter a, article 67, article 72 and article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

Central Election Commission after reviewing the documentation submitted by the Alliance Party Democratic Party "and heard the discussions of representatives of political parties,

V Ë R E N:

The "Democratic Alliance" party, has been registered as an electoral subject for elections to the organs of

local government of June 30, 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" amended, the Party "Democratic Alliance" has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 12.05.2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the municipal council of the Party "Democratic Alliance" and the accompanying documentation submitted and noted the shortcomings of the documentation as follows :

1. Identification document and declarations of multi-name list candidates. Under these conditions CEC should:

To return the candidature documentation for correction of the identified deficiencies, from the Democratic Alliance Party.

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Returns for completing the documentation for the registration of the multi-name list of candidates for members of the Kamza City Council, of the Democratic Alliance Party, for elections to the local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
