AT THE TIRANA MUNICIPAL COUNCIL DEPOSIT BY THE PARTY "DEMOCRATIC
ALLIANCE" FOR ELECTIONS TO THE LOCAL GOVERNMENT BODIES OF 30 JUNE
2019**

OBJECT: For return to complete the multi-name list of candidates for members of the Tirana City Council deposited by the Democratic Christian Alliance Party for elections to local government bodies of 30 June 2019

LEGAL REFERENCE: Article 23, paragraph 1, letter a, article 67, and article 72 and article 73, point 1 Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania"

The Central Election Commission after reviewing the documentation submitted by the Balli Kombëtar Party as well heard the discussions of representatives of political parties,

NOTES:

The Democratic Christian Alliance Party has been registered as an electoral subject for elections to local government bodies on June 30, 2019.

Pursuant to Article 67 and Article 72 of Law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania ", the Demo-Christian Alliance Party has submitted to CEC documentation for the approval of multi-name lists.

The Democratic Christian Alliance Party is a member of the ASE coalition.

At the meeting of May 18, 2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name list of candidates for members of the Council of the Demochristian Alliance Party and the accompanying documentation submitted and found the deficiencies of the documentation as follows:

1. Gender quota is not respected in the multi-name list Model 10 K;
2. Declaring the gender quota completed not according to gender distribution;
3. Birth certificate / personal or copy of identification document to candidates with no 4,6,13,14,17,18,20,22,25,27,28,29,30,31,32,33;
4. Declaration of candidate with ordinal number 05;
5. Self-declaration form for candidates with ordinal number from 28-33.

Under these conditions CEC should:

To return the candidature documentation for correction of the deficiencies ascertained by the "Party" Democratic Christian Alliance ".

FOR THESE REASONS:

The Central Election Commission, based on Article 23, point 1, letter "a", article 67, points 1, 4, 5 and 6, article 72 and article 73, point 1 of law no. 10019, dated 29.12.2008 " Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for completing the documentation for the registration of the multi-name list of candidates for members of the Tirana City Council, of the Democratic Christian Party, for the elections for the local government bodies of 30 June 2019.

2. This decision shall enter into force immediately.

3. An appeal may be filed against the decision to the Electoral College at the Tirana Court of Appeal within
5 days after his announcement.
