FOR RETURN TO COMPLETE THE MULTINAME LIST OF CANDIDATES FOR MEMBERS AT THE MUNICIPAL COUNCIL OF FIER, DEPOSITED BY THE NEW EUROPEAN DEMOCRACY PARTY, FOR ELECTIONS FOR THE LOCAL GOVERNMENTS BODIES OF 30 JUNE 2019

OBJECT: For return to complete the multiname list of candidates for member at the municipal council of Fier, deposited by the new European Democracy party. For elections for the local government bodies of 30 June 2019

LEGAL REFERENCE : Article 23, point 1, letter a, article 67, article 72 and article 73, paragraph 1, of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

Central Election Commission after reviewing the documentation submitted by the neNew European Democracy" Party , and heard the discussions of representatives of political parties,

NOTES:

The "New European Democracy" party has been registered as an electoral subject for elections to local government bodies on June 30, 2019.

Pursuant to Article 67 and Article 72 of Law no. 10019, dated 29.12.2008 The "Electoral Code of the Republic of Albania" as amended, the "New European Democracy" Party has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name list of candidates for members of the Council of the European New Democracy Party and the accompanying documentation submitted and found the deficiencies of the documentation as follows:

1. Certificate of possession of the mandate in the Assembly according to article 68, point 2 of the Code

Elected Election / Voters List Supporting the Party / Coalition;

2. Required number of candidates on the list according to article 67 point 5;

3. Gender quota is not respected in the multi-name list Model 10 K;

4. Declaring the gender quota completed not according to gender distribution;

Under these conditions CEC should:

To return the candidature documentation for correction of the identified deficiencies from the New Democracy European Party.

FOR THESE REASONS:

The Central Election Commission based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for completing the documentation for the registration of the multi-name list of candidates for Fier City Council members of the Party of European Democracy for the Elections for Local Government Elections of 30 June 2019.

2. This decision shall enter into force immediately.

3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals
Tirana, within 5 days of its announcement.
