**FOR RETURN TO COMPLETE THE MULTINAME LIST OF CANDIDATES FOR MEMBERS
AT THE MUNICIPAL COUNCIL OF FIER, DEPOSITED BY THE NEW EUROPEAN
DEMOCRACY PARTY, FOR ELECTIONS FOR THE LOCAL GOVERNMENTS BODIES OF
30 JUNE 2019**

OBJECT: For return to complete the multiname list of candidates for member at the municipal council of Lezha, deposited by the National Unity Party. For elections for the local government bodies of 30 June 2019

LEGAL REFERENCE : Article 23, point 1, letter a, article 67, article 72 and article 73, paragraph 1, of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

Central Election Commission after reviewing the documentation submitted by the Unity National " Party , and heard the discussions of representatives of political parties,

NOTES:

The party of "National Unity" has been registered as an electoral subject for elections to the organs of local government bodies of June 30, 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" as amended, the "National Unity Party" has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, based on Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the Municipal Council of the National Unity Party and the accompanying documentation submitted and noted the deficiencies of the documentation as follows :

1. Gender quota is not respected in the multi-name list Model 10 K;
2. Declaration for countries by gender quota Model 09 K;
3. Identification document and declaration of candidates for members of the municipal council

Under these conditions CEC should:

To return the candidacy documentation for correcting the deficiencies found by the Party of "National Unity".

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for completion of documentation for the registration of the multi-name list of candidates for members of the Lezha Municipal Council, of the National Unity Party, for the elections for the local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
