**ON VERIFICATION OF DECLARATIONS FORMS CANDIDATES FROM THE
MULTINAME LIST FOR THE MUNICIPAL COUNCIL OF THE PARTY FOR PROTECTION
OF THE RIGHTS OF WORKERS IN IMPLEMENTING LAW NO. 138/2015 "ON THE
GUARANTEE OF PERSONAL INTEGRITY SELECTED, APPOINTED OR EXERCISING
PUBLIC FUNCTIONS" FOR ELECTIONS FOR LOCAL GOVERNMENT BODIES OF 30
JUNE 2019**

OBJECT: On verification of declarations forms candidates from the multiname list for the municipal council of the party of the right of workers in implementin law no. 138/2015 " On the guarantee of personal integrity selected, appointed or exercising public functions" for elections for local government bodies of 30 june 2019

LEGAL REFERENCE: Article 23, point 1, letter "a", of the law no. 10019 dated 29.12.2008 "Electoral Code of the Republic of Albania", as amended; Article 5, paragraph 4, letter "a" of Law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions"; Chapter V, of Assembly Decision no. 17/2016 "On the establishment of detailed rules on the implementation of the prohibitions provided by law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

The Central Election Commission after reviewing the submitted documentation and listening to the discussions of the attendees,

NOTES:

The Party for the Protection of Workers Rights, in accordance with Article 5, paragraph 4, letter "a" of Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions" has filed in the Central Election Commission the self-declaration forms of candidates for the municipal council of Kërcyra as the competent body for administration, verification, enforcement of prohibitions for election and appointment to the public function including the function of the councilor of the municipality.

Pursuant to the law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", the CEC has verified the data in the self-declaration forms for each multi-name list candidate.

By verifying the self-declaration forms, the candidates for members in the municipal councils, for Kërcyra Municipality, none of them has stated any data related to the prohibition provisions in Law no. 138/2015, "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

The judicial office has sent to the Central Election Commission, verifying the judicial status of the candidates for members in the municipal councils of Kërcyra, which result that results are unjustified by the Albanian courts,

The Central Election Commission, referred to point 2, last paragraph, of Chapter V of Decision no.17/2016 of the Assembly, ascertains that for the persons listed on the multi-name list their data do not constitute a condition for not registering as a candidate for the municipal council, according to the law no.

138/2015. The CEC has also published the self-declaration forms on its official website website.

Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions", Article 4 provides for the period during which the provisions of this law for the prohibition, candidacy, election or exercise of the function shall apply, depending on type of criminal offense declared / convicted.

Referring to article 33, letter "f" of the Electoral Code, the Electoral Administration Zone Commission has the power to register candidates for elections to local government bodies in those municipalities that are administered by a CEAZ.

Referring to Law no. 138/2015 "On guaranteeing the integrity of the persons elected, appointed or exercising public functions" and point 5/1, 6 of the article 9 of the instruction no.2, dated 29.01.2013 "On setting the rules for depositing and verification of documentation and the deadlines for the publication of the candidates' lists, the CEAZs should continue the procedures for the registration of the multi-name list for the council of the Workers' Rights Protection Council for Local Government Elections of 30 June 2019.

FOR THESE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter a, Article 67, paragraph 1 of law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", as amended.

DECIDED:

1. The refusal of the National Conservative Party Albania's application for the submission of documents for the registration of candidates for mayor and the multi-name list of candidates for members of the Municipal Council for elections to local government bodies dated 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
