**OBJECT:** For the return and correction of the multi-name list of the candidates for members of the municipality of Korçë, deposited by the Party "Albanian Democracy Alliance" for the elections to local government bodies of 30 June 2019.

**LEGAL BASIS:** Article 23, point 1, letter a, article 67, article 72, article 73, point 1, of law nr. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania"

The Central Election Commission, after examining the presented documentation by the party "Albanian Democratic Alliance", and heard the discussions of the representatives of the political parties,

The party "Albanian Democratic Alliance" has been registered as an electoral subject for elections to local government bodies on June 30, 2019.

For the return and correction of the multi-name list of the Party "Albanian Democratic Alliance" for the elections to local government bodies of 30 June 2019.

In accordance to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended, the Party "Albanian Democratic Alliance" has submitted to CEC the documentation for the approval of the multi-name lists.

In the meeting of 18.05.2019, in accordance to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name list of candidates for members of the municipality council of the party "Albanian Democratic Alliance" and the accompanying documentation submitted and noted lack of the documentation as follows :

1. Declaration for the places according to the gender quota Model 09K;
2. Identification documents and candidate declarations for members of the municipality council.

In these conditions the CEC must:

Return the candidacy documentation for correction of the shortcomings found by the party "Albanian Democratic Alliance".

#### **FOR THESE REASONS:**

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania ", as amended.

#### **DECIDED:**

1. Return for correction of the documentation for the registration of the multi-name list of the candidates for members of the municipality council of Korçë, of the party "Albanian Democratic Alliance", for the elections to the local government bodies of 30 June 2019.
2. This decision goes effective immediately.
3. A complaint can be filed against this decision at the Electoral College at the Tirana Court of Appeal within 5 days of its announcement.
