OBJECT: For the return and correction of the multi-name list of the candidates for members of the municipality of Durrës, deposited by the party "New Democratic Spirit" for the elections to local government bodies of 30 June 2019.

LEGAL BASIS: Article 23, point 1, letter a, article 67, article 72, article 73, point 1, of law nr. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania"

The Central Election Commission, after examining the presented documentation by the party "New Democratic Spirit", and heard the discussions of the representatives of the political parties,

NOTES:

The "New Democratic Spirit" party has been registered as an electoral subject for elections to local government bodies on June 30, 2019.

For the return and correction of the multi-name list of the candidates for members of the municipality of Durrës, deposited by the party "New Democratic Spirit", for the elections to local government bodies of 30 June 2019.

In accordance to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended, the Party "New Democratic Spirit" has submitted to CEC the documentation for the approval of the multi-name lists.

In the meeting of 18.05.2019, in accordance to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name list of candidates for members of the municipality council of the party "New Democratic Spirit" and the accompanying documentation submitted and noted lack of the documentation as follows :

1. The number of the candidates is smaller than half the number of the mandates in the municipality council, from 51 they have deposited 29;
2. The gender quota in the multi-name list Model 10K, has not been respected;
3. Declaration for the places according to the gender quota Model 09K;
4. The Declarations of the candidates for members of the municipality council.

In these conditions the CEC must:

Return the candidacy documentation for correction of the shortcomings found by the "New Democratic Spirit" Party.

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for correction of the documentation for the registration of the multi-name list of the candidates for members of the municipality council of Durrës, of the party "New Democratic Spirit", for the elections to the local government bodies of 30 June 2019.
2. This decision goes effective immediately.
3. A complaint can be filed against this decision at the Electoral College at the Tirana Court of Appeal within 5 days of its announcement.
