LEGAL BASIS: Article 23, point 1, letter "a", Article 164, point 2 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended

The vacancy fulfillment will be made by selecting from the list of citizens approved by the CEC by decision no. 140, dated 09.04.2019, according to the procedure set forth in the Instruction no. 04 dated 19.02.2013, as amended by Decision no.127, dated 04.04.2019.

The Central Election Commission based on Article 23, paragraph 1, letter "a" of law nr. 10019 dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended
