**OBJECT:** For the declaration of the final results for the election of the mayor of the municipality of Lushnje, Fier Region, in the local elections of 30 June 2019.

**LEGAL BASIS:** Article 21, point 7, article 23, point 1, letter "a", article 123, of Law No. 10019, dated 29.12.2009 "The Electoral Code of the Republic of Albania", amended;

The Central Election Commission, after examining the documents presented and heard the discussion of the people present

**NOTES**

The Electoral Area of Lushnje Municipality in its territory is divided into 2 EAZs. In this case, the CEC verifies and declares the result for the electoral zone, based on the result tables issued by each CEAZ of the respective electoral zone.

At the end of the delivery process of the Summary Tables and Results Tables for each voting center for the mayor of the municipality of Lushnje from the two CEAZs of this municipality, the CEC declares the result for this electoral zone, following the procedures provided for in Article 123 of the Code.



Prior to the completion of the Summary Table of the Results for the Election of Mayor of Lushnje, the Result Tables were compared to the candidates of the voting centers of these CEAZs, supplemented by the Counting Teams with Summary Tables of the Outcome adopted by the CEAZ no. 54, CEAZ no. 55, and their result put into the electronic system resulted that:

- The Summary Tables of Results adopted by the CEAZ no. 54, CEAZ no. 55, include the result of all tables of the results of the VC that these EAZs have.
- By comparing the result tables for each voting center with the summary table of the result of the respective EAZ and their result placed on the electronic system, there is no discrepancy in the data.

The CEC will adopt by Decision the Summary Table of the Results for the Election of the Mayor of Lushnje, Fier Region, based on the results tables issued by each CEAZ and the original results tables of each voting center of this municipality, supplemented by the ballot counting team.

### **FOR THESE REASONS**

The Central Election Commission, based on Article 21, point 7, Article 23, point 1, letter "a", Article 123, of Law No. 10019, dated 29.12.2009 "The Electoral Code of the Republic of Albania" amended,

### **DECIDED:**

1. To approve the Summary Table of the Results for the Election of the Mayor of Lushnje, Fier Region, attached to this decision.
2. This decision goes effective immediately.
3. An appeal can be submitted against this decision in the Electoral College at the Tirana Appeal Court, within five days from its publication.
