The President of the Republic, pursuant to Article 92, letter "gj", and Article 93 of the Constitution of the Republic of Albania, and Article 9, paragraph 1, of the Law no. 10019, dated 29.12.2008 The "Electoral Code of the Republic of Albania" as amended, with the Decree no. 10928 dated 05.11.2018 set June 30, 2019 as the date of local government elections.

Mr. Fabian Topollari, representative and acting on behalf of Democratic Belief Party, submitted to the Central Election Commission a request and the relevant documentation to be registered as an electoral subject for local government elections of June 30, 2019, registered with protocol no.2499, dated 23.04.2019

The request is filed within the deadline provided for in the first paragraph of Article 64 of the Electoral Code, as amended.

In addition to the request, Democratic Belief Party has submitted the following documentation:

- The certificate with protocol no. 1160/1, dated 26.04.2019, issued by Tirana District Court, on 26.04.2019, through which it is certified that Tirana District Court, with its decision no.8, dated 25.04.2019, - a decision which is not of a final form- decided to register Democratic Belief Party as a juridical entity in political parties' register, Tirana District Court, with temporary chairman Mr. Astrit Patozi, the official name, initials and address of the party and specimen of the stamp;

- first name, last name and address of the temporary chairman of the party;

- the initials and the address of the party

- the specimen of the stamp of the party;

- first, last name and the address of the finance officer of the party (Mrs.Estela Kondura)

- full name and the address of the person responsible for the communication with the CEC (Mr. Fabian Topollari);
