**ON ALLOCATION OF MANDATES FOR THE COUNCIL OF MALLAKASTER MUNICIPALITY,
FIER REGION, FOR June 21, 2015 LOCAL GOVERNMENT ELECTIONS**

Reviewed the matter with the following:

OBJECT: Allocation of terms for Municipality Council of **MALLAKASTER MUNICIPALITY, FIER** district, in Local Government elections of June 21, 2015.

LEGAL BASIS: Article 21, item 7 and Article 166, item 3 of the Law No.10019, dated 29.12.2008 The Electoral Code of the Republic of Albania.

The CEC, after examining the submitted documentation and hearing the discussions of representatives of political parties

NOTES

CEAZ No. 61 with its decision no.137, dated 24.06.2015, adopted the Aggregate Table of Results for MALLAKASTER MUNICIPALITY Council, FIER region. No election subject appealed against this decision of CEAZ No.61 according to the deadlines set by law. According to Article 166, paragraph 3, of the Electoral Code of the Republic of Albania, the CEC calculates the allocation of seats for the council.

The result of MALLAKASTER MUNICIPALITY council, for coalitions, parties that run independently and the candidates proposed by the voters is as follows:

According to Article 162, paragraph 2, the number of valid votes at the election zone level, for each subject is divided by consecutive natural numbers, called denominator, starting with number 1 and ending with the natural number corresponding to number of seats to be allocated to the Council of MALLAKASTER MUNICIPALITY, which according to the letter of the Prefect of FIER, region No.503/2, dated 09.04.2015 is 21.

According to Article 162, paragraph 4, the quotient obtained by each division, is ranked from the largest quotient to the smallest, listing the subject next to them, to which the quotient belongs. According to Article 162, paragraph 5, an electoral entity receives a number of seats equal to the number of quotients included in the above list.

At the end of the above steps, we achieve the following result for on allocation of seats:

Pursuant to Article 163 of the Electoral Code of the Republic of Albania, the CEC must calculate the distribution of seats within the coalitions that won mandates for the respective council.
