29.12.2008, The Electoral Code of the Republic of Albania” as amended, with the Decree no.10928, dated 05.11.2018 set June 30, 2019, as the date of local government elections.

The Alliance for Democracy and Solidarity Party, with initials ADS, through its chairman, Mr. Gaqo Apostoli, submitted to the CEC the request and the respective documentation, with prot.no. 2175, dated 04.04.2019 in order to be registered as electoral subject for local government elections to be held on June 30, 2019.

The request submitted by the Alliance for Democracy and Solidarity Party meets the deadline stipulated in item 1, article 64 of the Electoral Code, as amended.

After reviewing the documentation attached to the request, the CEC found that it is in full compliance, in terms of the form and content, with the item 2, article 64 of the Electoral Code, as amended.

Specifically, it has submitted:

- The certificate issued by the Political Parties Registration Office in Tirana District Court, dated 02.04.2019, through which it is certified that the Alliance for Democracy and Solidarity Party, with the initials ADS and chaired by Mr. Gaqo Apostoli, is registered in this Office;
- first, last name and the address of the chairman of the party;
- official name, initials and the address of the party ;
- specimen of the seal of the party;
- first, last name and the address of the finance officer of the party (Mr.Oldi Cane)
- first, last name and the address of the person responsible for the communication with the CEC (Mr. Agron Leskoviku);

The Central Elections Commission, after making the respective checks, and after finding that the request and the documentation submitted by the Alliance for Democracy and Solidarity Party are in compliance with the criteria defined in article 64 of the law no. 10019, dated 29.12.2008 “The Electoral Code of the Republic of Albania” as amended,

DECIDED:

1. To register the Alliance for Democracy and Solidarity Party with initials “ADS”, chaired by Mr.Gaqo Apostoli, as electoral subject for local government elections of June 30, 2019.
2. This decision comes immediately into effect.
3. An appeal can be filed against this decision in the Electoral College of Tirana Court of Appeals, within 5 days from its publication.
