**OBJECT**            On release from duty and appointment of the member of CEAZ no.33, secretary of CEAZ no.33, secretary of CEAZ no.35 and release and appointment of the secretary of CEAZ no.70 for June 30, 2019 local government elections

**LEGAL REFERENCE:** Article 23, item 1, letter “a”, article 21, item 11, article 29, item 5, article 32, item 1, letter d of the Electoral Code of the Republic of Albania

The CEC, after reviewing the submitted documentation and heard the discussions of those present,

## NOTES

The Socialist Party of Albania, with its letter with prot. No.2310, dated 11.04.2019, based on article 32, item 2, letter “d”, of the Electoral Code, has requested the release from duty and appointment of the member of CEAZ no.33, Tirana Region, release from duty and appointment the secretary of the CEAZ No.33, Tirana Region, release from duty and appointment the secretary of the CEAZ No.35, Tirana Region.

The Central Elections Commission, after reviewing the documentation submitted by the Socialist Party of Albania, concerning the proposals for members and secretaries of the CEAZs, found them in compliance with the requirements of article 30 and 31 of the Electoral Code.

The Central Elections Commission, with its Decision no.141, dated 09.04.2019, filled the vacancy created in CEAZ no. 70, by appointing in the position of secretary Freskida Shullëri. This national was not present in the meeting called by the CEAZ no. 70, held on April 11, 2019 and could not be reached even after the meeting. Due to her failure to be present as the appointed secretary of CEAZ no.70, the position of the CEAZ secretary is still open. The CEC finds that the vacancy is still open and based on article 32, item 1, letter c of the Electoral Code, releases from duty and fills the vacancy by selecting from the list of the nationals who were approved by a CEC Decision no.140, the nationals that meet the requirements of the article 30 and 31 on the appointment of the secretary of the CEAZ no.70.

### **FOR THESE REASONS,**

The Central Elections Commission, based on article 23, item 1, letter “a”, article 21, item 11, article 29, item 5, article 32, item 1, letter “d”, of the Electoral Code of the Republic of Albania,

### **DECIDED:**

- 1.To release from duty and appoint the member and secretaries of the CEAZs based on the request of the electoral subject Socialist Party of Albania, according to link no.1
- 2.To appoint the member and the secretary of the CEAZs, proposed by the electoral subject Socialist Party of Albania, according to link no. 2.
- 3.To release from duty the secretary appointed in CEAZ no.70, according to the link no.1.
- 4.To appoint the secretary of CEAZ no.70 according to the link no.2.
- 5.This decision comes immediately into effect.
6. A complaint can be filed against this decision in the Electoral College in Tirana Court of Appeals, within 5 days from its publication.
