OBJECT: For the registration of candidate for mayor of Shkodra, Mr. Valdrin Luigj Pjetri, proposed by the coalition "Alliance for European Albania", for the elections for the local government bodies of 2019.

LEGAL REFERENCE: Article 23, point 1, letter "a", article 67, point 2, article 165, point 3 article 72 and article 73, point 1 of law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania "

The Central Election Commission after reviewing the documentation submitted by the coalition "Alliance for European Albania" and hearing the discussions of representatives of political parties,

NOTICED :

By the CEC decision no. 251, dated 07.05.2019, the Coalition "Alliance for European Albania" has been registered as an electoral subject for elections to local government bodies of June 30, 2019. According to the agreement of the Coalition "Alliance for European Albania", the chairman of the Socialist Party of Albania, Edi Rama will be the person who will authorize persons responsible for signing on behalf of the coalition the application for registration of candidates for mayor.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", Coalition "Alliance for European Albania" has deposited at CEC a request for the registration of Mr. Vadrin Peter as candidate for mayor of Shkodra.

Pursuant to Article 67, paragraph 3, the CEC must register candidates for mayor or council of Shkodra Municipality, since the Municipality of Shkodra is administered by more than one CEAZ. Attached the application is filed and the relevant documentation, as listed below:

1. Request for registration of Mr. Valdrin Luigj Peter, mayor candidate of Shkodra;
2. Declarations of the candidate declaring that he enjoys the right and will to run for mayor in the Municipality of Shkodra, proposed by the Coalition "Alliance for European Albania" in the elections for the local government bodies of 30.06.2019;
3. Certificate of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, according to which it is proved that the Socialist Party is represented by 74 members of the Assembly of the Republic of Albania.
4. Copy of the ID card of Mr. Valdrin Luigj Peter, according to which it turns out that Mr. Vadrin Peter lives in the Municipality of Shkodra;
5. Graphic design;
6. The self-charter form, pursuant to law no. 138/2015 "On guaranteeing integrity of persons elected, appointed or exercising public functions ".
7. Official record of filing of the candidacy documents.

FOR THESE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter "a", article 67, points 2, 4, 5 and 6, Article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "The Electoral Code Republic of Albania ".

DECIDED:

1. To register as candidate for Mayor of the Municipality of Shkodra for elections for local government bodies of 30 June 2019, Valdrin Luigj Pjetri proposed by the Coalition "Alliance for European Albania".
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
