Reviewed the case with the following

OBJECT: On Registration of the Party for Protection of Emigrants' Rights as electoral subject for June 30, 2019 local government elections

LEGAL REFERENCE Article 23, item 1, letter a, article 64 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended.

The CEC, after reviewing the documentation submitted and hearing the discussions of the representatives of political parties,

NOTES

The President of the Republic, pursuant to Article 92, letter "gj", and Article 93 of the Constitution of the Republic of Albania, and Article 9, paragraph 1, of the Law no. 10019, dated 29.12.2008 The "Electoral Code of the Republic of Albania" as amended, through the Decree no. 10928 dated 05.11.2018 set June 30, 2019 as the date of local government elections.

The Party for Protection of Emigrants' Rights, with initials "PMDE", through its chair, Mr. Ymer Kurti, has submitted to the Central Election Commission a request with prot no.2303,

dated 11.04.2019 and the relevant documentation to be registered as an electoral subject for local government elections of June 30, 2019.

The request filed by the Party for Protection of Emigrants' Rights is within the deadline provided for in item 1, Article 64 of the Electoral Code, as amended.

Based on the review of the documentation attached to the request, the CEC found that it is in full compliance, in terms of the form and content, with the requirements in item 2, article 64 of the Electoral Code, as amended.

Specifically, it has submitted:

-The certificate issued by the Registration Office of Political Parties, in Tirana District Court, dated 13.03.2019, through which it is certified that the Party for Protection of Emigrants' Rights, with the initials "PMDE" and chaired by Mr. Ymer Kurti is registered in this Office;

- first, last name and the address of the chairman of the party; -

- official name, initials and the address of the party ;

- specimen of the seal of the party; - first, last name and the address of the finance officer of the party (Mr.Enkeled Agazi)

- full name and the address of the person responsible for the communication with the CEC (Mrs. Kimete Groshua);

The Central Elections Commission, after making the respective checks, and after finding that the request and the documentation submitted by the Party for Protection of Emigrants' Rights, are in compliance with the criteria defined in article 64 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania" as amended,

1. To register the Party for Protection of Emigrants' Rights, chaired by Mr. Ymer Kurti, with initials "PMDE", as electoral subject for local government elections of June 30, 2019.
2. This decision comes immediately into effect.
3. An appeal can be filed against this decision in the Electoral College of Tirana Court of Appeals, within 5 days from its publication.
