OBJECT: On the registration of the candidate for Mayor of Lezhë proposed by the National Conservatory Party of Albania for the elections to local government bodies of 30/05/2019

LEGAL BASIS: Article 23, point 1, letter "a", article 67, point 2, article 165, point 3, article 72 and article 73 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended.

Central Election Commission, after examining the documents submitted by the "National Conservatory Party of Albania" and heard the discussions of representatives of political parties,

NOTES:

In accordance to Article 67, point 2 and article 72 and 165 of Law nr.10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", the "National Conservatory Party of Albania" has deposited to the CEC the request for the registration of Mr. Eduard Ndocaj as a candidate for mayor of Lezha.

On the registration of the candidate for Mayor of Lezhë proposed by the National Conservatory Party of Albania for the elections to local government bodies of 30/05/2019.

In accordance to Article 67, point 3, the CEC must register candidates for mayor or municipal council of the municipality of Lezha, because the Municipality of Lezha is administered by more than one CEAZs.

Attached to the application, the relevant documentation has been also deposited, listed as following:

1. Application for registration of Mr. Eduard Ndocaj candidate for mayor of Lezha;
2. Candidate statements which declares that he enjoys the right and the will to candidate for Mayor of the Municipality of Lezhe, proposed by the "National Conservatory Party of Albania" for the elections to local government bodies of 30.06.2019;
3. Confirmation of Parliament, no. 13 prot., Dated 13.05.2019, under which it is verified that Mr. Kujtim Gjuzi is declared as a representative of the subject "National Conservatory Party of Albania" and independent.
4. Confirmation of the Municipality Council of Lezha, nr. 4751/1 prot, date 13.05.2019, according to which it is verified that Mr. Petrit Gjon Ndreu, member of the Municipality Council of Lezha, proposed by the political subject "National Conservatory Party of Albania".
5. Candidate's copy of identification card under which results that Mr. Viktor Tushaj is residing in the Municipality of Lezha.
6. CV
7. Self-declaration form, in accordance to law nr. 138/2015 "To guarantee the integrity of persons elected, appointed or exercise public functions"
8. Official record of the submission of the candidacy documents.

In accordance to law nr. 138/2015 "To guarantee the integrity of persons elected, appointed or exercise public functions", the CEC verified all the information on the self-declaration forms of the candidate for mayor of the municipality of Lezha. The CEC has also published the self-declaration form on the official webpage online.

From the verification of the information declared on the self-declaration form and information gotten from the General Directorate of Prisons, Mr. Eduart Ndocaj is not on the condition of article 2, of law nr. 138/2015 " to be refused as a candidate for mayor, proposed by "National Conservatory Party of Albania".

The CEC, based on article 73, point 1, of the Electoral Code, in its meeting on 16.05.2019, verified the documentation of the candidate for mayor, Mr. Eduart Ndocaj in the municipality of Lezha. Deposited by the "National Conservatory Party of Albania" and states that it was in compliance with the requests provided in article 67, point 2, article 165 article 72 and article 73 of the Electoral Code.

FOR THE ABOVE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter or article 67, points 2,4,5 and 6 article 72, and article 73, point 1 of Law nr.10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended,
