OBJECT: On the registration of the candidate for Mayor of Maliq Municipality, Korçë proposed by the Coalition "Alliance for European Albania" for the elections to local government bodies of 30/05/2019

LEGAL BASIS: Article 23, point 1, letter "a", article 67, point 2, article 165, point 3, article 72 and article 73 of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended.

Central Election Commission, after examining the documents submitted by the Coalition "Alliance for European Albania" and heard the discussions of representatives of political parties,

NOTES:

With the decision of the CEC No.251, dated 16.05.2019, the coalition "Alliance for European Albania" has been registered as an electoral subject for elections to local government bodies of June 30, 2019. According to the agreement of the Coalition "Alliance for European Albania", the chairman of the Socialist Party of Albania, Mr. Edi Rama will be the person who will authorize the responsible persons to sign on behalf of the coalition the request for registration of candidates for mayor.

On the registration of the candidate for Mayor of Maliq Municipality proposed by the Coalition "Alliance for European Albania" for the elections to local government bodies of 30/05/2019.

In accordance to Article 67, point 2 and article 72 and 165 of Law nr.10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", the Coalition "Alliance for European Albania" has deposited to the CEC the request for the registration of Mr. Gëzim Topçiu as a candidate for mayor of Maliq Municipality.

In accordance to Article 67, point 3, the CEC must register candidates for mayor or municipal council of the municipality of Maliq, because the Municipality of Korca is administered by more than one CEAZs.

Attached to the application, the relevant documentation has been also deposited, listed as following:

1. Application for registration of Mr. Gëzim Topçiu candidate for mayor of Maliq Municipality;
2. Candidate statements which declares that he enjoys the right and the will to candidate for Mayor of the Municipality of Maliq, proposed by the Coalition "Alliance for European Albania" for the elections to local government bodies of 30.06.2019;
3. Confirmation of Parliament, no. 1851/1 prot., Dated 09.05.2019, under which it is verified that the Socialist Party is represented by 74 parliamentarians in the Assembly of Albania.
5. Candidate's copy of identification card under which results that Mr. Gëzim Topçiu is residing in the Municipality of Maliq.
6. CV
7. Self-declaration form, in accordance to law nr. 138/2015 "To guarantee the integrity of persons elected, appointed or exercise public functions"
8. Official record of the submission of the candidacy documents.

In accordance to law nr. 138/2015 "To guarantee the integrity of persons elected, appointed or exercise public functions", the CEC verified all the information on the self-declaration forms of the candidate for mayor of the municipality. The CEC has also published the self-declaration form on the official webpage online.

From the verification of the information declared on the self-declaration form and information gotten from the General Directorate of Prisons, Mr. Gëzim Topçiu is not on the condition of article 2, of law nr. 138/2015 " to be refused as a candidate for mayor, proposed by the Coalition "Alliance for European Albania"

The CEC, based on article 73, point 1, of the Electoral Code, in its meeting on 16.05.2019, verified the documentation of the candidate for mayor, Mr. Gëzim Topçiu in the municipality of Maliq, deposited by the Coalition "Alliance for European Albania" and states that it was in compliance with the requests provided in article 67, point 2, article 165 article 72 and article 73 of the Electoral Code.

FOR THE ABOVE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter or article 67, points 2,4,5 and 6 article 72, and article 73, point 1 of Law nr.10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended,
