# ON RETURNING OF MULTI-MEMBER LIST OF CANDDIATES FOR DURRES MUNICIPALITY COUNCIL FILED BY ALLIANCE FOR DEMOCRACY AND SOLIDARITY TO BE COMPLETED, FOR JUNE 30, 2019 LOCAL GOVERNMENT ELECTIONS

**OBJECT:** On returning to be completed the multi member list of candidates for

Durres municipality council, filed by Alliance for Democracy and

Solidarity, for June 30, 2019 local government elections

**LEGAL REFERENCE** Article 23, item 1, letter a, article 64 and 6, article 72 and 73 of the

law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic

of Albania" as amended.

The CEC, after reviewing the documentation submitted by the Party Alliance for Democracy and Solidarity, and hearing the discussions of the representatives of political parties,

### **NOTES**

The Party Alliance for Democracy and Solidarity is registered as electoral subject for local government elections of June 30, 2019.

Based on article 67 and article 72 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", as amended, the Party Alliance for Democracy and Solidarity has submitted to the CEC the documentation on adoption of the multi-member lists. In its meeting on 17.05.2019 based on article 73, of the Electoral Code, the Central Elections Commission checked the multi-member lists of the candidates for council members of the Party Alliance for Democracy and Solidarity and the documentation attached to it and found that the following documents were missing

- 1. Model 13-K;
- 2. The gender quota in the multi-member list Model 10K is not met
- 3. The self declaration form for all the candidates;

Under these conditions, the CEC shall: return the candidacy documents, in order to correct the shortcomings noted".

### FOR THESE REASONS:

The Central Elections Commission, pursuant to article 23, item 1, letter a, article 67, item 1,4,5 and 6 and article 72 and 73 of the law no. 10019, dated 29.12.2008,"The Electoral Code of the Republic of Albania", as amended,

## **DECIDED:**

- 1. To send back the documentation in order to be completed, on registration of the multi member list of the candidates for municipality council members of Durres municipality, of the Party Alliance for Democracy and Solidarity, for local government elections of June 30, 2019.
- 2. This decision comes immediately into effect.
- 3. An appeal can be filed against this decision in Electoral College, Tirana Court of Appeals, within 5 days after its publication.
