OBJECT: On the registration of the candidate for the member in municipal council of Elbasan municipality proposed by the party "Bindja Demokratike" Mr. Albert Rrapush Shopi on elections for local government bodies dated 30 June 2019.

LEGAL REFERENCE: Article 23, point 1, letter "a", article 67, point 2, article 165, point 3 article 72 and article 73 point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

The Central Election Commission, after reviewing the documentation submitted by the party "Bindja Demokratike" and hearing the discussions of representatives of political parties,

NOTES :

By the CEC decision no. 230, date 24.04.2019, the party "Bindja Demokratike" was registered as an electoral subject for elections to local government bodies on 30 June 2019.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", the party "Bindja Demokratike" has submitted to in the CEC their request for registration of Mr. Albert Rrapush Shopi as candidate for member in municipal council of Elbasan municipality .

By the CEC decision no. 230, date 24.04.2019, the party " Bindja Demokratike" was registered as an electoral subject for elections to local government bodies on 30 June 2019.

Pursuant to Article 67, paragraph 2 and Article 72 and Article 165, point 3 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", the party " Bindja Demokratike " has submitted to the CEC their request for registration of Mr. Albert Rrapush Shopi as candidate for member in municipal council of Elbasan municipality.

Pursuant to Article 67, paragraph 3, the CEC shall register candidates for mayor or for the Elbasan municipal council, since Elbasan Municipality is administered by more than one CEAZ.

The attached request and the relevant documentation are submitted to the CEC as listed below:

1. Request for registration of Mr. Albert Rrapush Shopi as candidate for member in municipal council of Elbasan municipality.
2. Declarations of the candidate declaring that he has the right and will to run for candidate for member in municipal council of Elbasan municipality , proposed by Bindja Demokratike in the elections for the local government bodies of 30.06.2019;
3. Copy of the ID card of Mr. Albert Rrapush Shopi
1. CV of Mr. , as candidate Rrapush Shopi as candidate for member in municipal council of Elbasan municipality.
2. The Self-Declaration Form, pursuant to Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

Mr. Albert Rrapush Shopi, referred to Law no. 138/2015 "On guaranteeing the integrity of the persons elected, appointed or exercising public functions" has submitted to the Central Election Commission on 13.05.2019 the self-declaration form with special number 4223.

Pursuant to the law no. 138/2015 "On guaranteeing the integrity of the persons elected, appointed or exercising public functions", verified the data in the self-declaration forms for the candidate for the Member at the Elbasan Municipal Council.

By verifying the data in the self-declaration form, Albert Rrapush Shopi, turns out that he has not declare the data that are criteria for his non-registration under Law 138/2015.

The CEC has also published self-declaration form on its official website.

By verifying the data declared in the self-declaration form and information received from the General Directorate of Prisons Mr. The Albert Rrapush Shop is not in compliance with Article 2 of Law no. 138/2015, for refusing him as a candidate for the Member of the Elbasan Municipal Council.

The Central Election Commission, based on Article 73, point 1 of the Electoral Code, in its meeting of May 19, 2019, verified the candidacy documentation for a Member at the Elbasan Municipal Council and found that it was in accordance with the requirements set out in Article 67 , points 2, 165 article 72 and article 73 of the Electoral Code.

The Central Election Commission, based on Article 73, item 1 of the Electoral Code, in its meeting of the 20.05.2019, verified the candidacy for member in municipal council, Albert Rrapush Shopi , in the Elbasan Municipality, submitted by the Bindja Demokratike Party and found that it was in
