OBJECT: On the approval of the multi-name lists, of the candidates for members of the municipalities councils, deposited by the "Green Party", member of the coalition "Alliance for European Albania" for the elections to local government bodies of 30.06.2019.

LEGAL BASIS: Article 23, point 1, letter "a", of Law No. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended; article 5, point 4, letter "a" of law nr.138/2015, "To guarantee the integrity of persons elected, appointed or exercise public functions"; head V, of Assembly Decision nr/ 17/2016 ""For the designation of detailed rules on the implementation of prohibitions provided in law nr. 138/2015" , "To guarantee the integrity of persons elected, appointed or exercise public functions"

Central Election Commission, after examining the documents presented by the "Green Party" and heard the discussions of the people present,

On the approval of the multi-name lists, of the candidates for members of the municipalities councils, deposited by the "Green Party", member of the coalition "Alliance for European Albania" for the elections to local government bodies of 30.06.2019.

The Green Party, with CEC decision no. 28, dated 22.02.2019, has been registered as an electoral subject for the elections for local government bodies of 2019. With CEC decision no. 251, dated 07.05.2019, the coalition "Alliance for European Albania" has been registered, part of which is the "Green Party" also.

In accordance to Article 67 and Article 72 of Law no. 10019, dated 29.12.2008 " The Electoral Code of the Republic of Albania ", they have deposited in the CEC the multi-name list of its candidates for members of the Municipal Councils for: Elbasan, Lezha, Korça, Kamza, Tirana.

In accordance to Article 67, paragraph 3, the CEC must register the candidates for mayor or for municipality councils for: Elbasan, Lezha, Korça, Kamza, Tirana, since the municipalities of Elbasan, Lezha, Korça, Kamza, Tirana, are administered by more than one CEAZ.

Attached is the application is filed and the relevant documentation, as follows:

1. Multi-name lists of the candidates per members of the Council of Municipalities Elbasan, Lezha, Korça, Kamza, Tirana;
2. Declarations of the multi-name candidates who declare that they enjoy the right and the will to run for council members in the Municipal Councils: Elbasan, Lezha, Korça, Kamza, Tirana, proposed by the Green Party;
3. Copy of identification documents for all the candidates of the multi-name lists;
4. Proof of the Assembly of Albania, no. 1851/1. prot., dated 09.05.2019, according to which it is verified that the Socialist Party is represented by 74 deputies in the Assembly of the Republic of Albania.
5. CVs for all candidates on the multi-name list;
6. The self-declaration form, in accordance to law no. 138/2015 "To guarantee the integrity of persons elected, appointed or exercising public functions ";
7. Official records of the submission of the candidacy documents.

In the meeting of 20.05.2019, in accordance to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of the candidates for the Municipal Councils of Elbasan, Lezha, Korca, Kamza, Tirana, of the Green Party and the documentation attached and stated that it is in compliance with the requirements laid down by Article 67, points 2, 4, 5 and 6 and Article 72 of the Electoral Code.

In accordance to law no. 138/2015 "On guaranteeing the integrity of the persons elected, appointed or exercising public functions ", the CEC verified the data on the forms self-declaration for each candidate of the multi-name list. From the verification of the self-declaration form, none of them has stated any data related to the provisions to prohibition in Law No.138 / 2015, " On guaranteeing the integrity of persons elected, appointed or exercising public functions".

The Central Election Commission has requested information from the state's office and judicial office through written requests and electronic mail for the candidates for members in the municipality councils who submitted the self-declaration forms to the Central Election Commission.

Multi-name list of the Municipality of Tirana:

1. The candidate with **serial number 07, Mr. Emiljano Kol Tokeqi**, based on the decision no. 1693 dated 20.12.2010, Tirana District Court was pleaded guilty to the criminal

offense of theft and based on articles 134/1, 51 of the Criminal Code and 406 Criminal Procedure Code he has been sentenced to 2 months imprisonment. Pursuant to Article 63 Criminal Code, the Court has ordered the suspension of the execution of the punishment of imprisonment with a replacement of the obligation to perform of a work of public interest for 80 hours.

2. The candidate with **serial number 21, Mr. Adrian Shyqëri Petrela**, based on decision no.195 dated 07.05.1990, Tirana District Court declared him guilty of insulting a person because of his duty and under Article 120 of the Criminal Code he was sentenced to 9 months of re-education through work by detaining also 1/6 of his payment. According to Article 69 Criminal Code he is rehabilitated.

The Central Election Commission, in reference to point 2, last paragraph, of chapter V of the decision no. 17/2016 of the Assembly, ascertains that for the persons listed in the multi-name list, their data do not constitute a condition for not being registering as a candidate for the municipal council, according to law no. 138/2015. The CEC has also published the self-declaration forms on the official web site.

Central Election Commission, based on Article 73, paragraph 1 of the Electoral Code, dated 20.05.2015, verified the multi-name list of the candidates for members of the Council Municipalities of: Elbasan, Lezha, Korça, Kamza, Tirana, and the attached documentation deposited by the "Green Party" and found it compliant with the requirements provided for in Article 67, paragraphs 2, 4, 5 and 6, Article 72 of the Electoral Code.

FOR THE ABOVE REASONS:

The Central Election Commission based on Article 23, paragraph 1, letter "a", article 67, points 2, 4, 5 and 6, and article 72 and 73, point 1 of law nr. 10019 dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended

DECIDED:

1. The approval of the multi-name lists of the candidates for members of the Municipal Councils of: Elbasan, Lezha, Korca, Kamza, Tirana, of the "Green Party", members of the Coalition "Alliance For European Albania" in the elections for local government bodies on June 30 2019, according to annex no. 1, attached to this decision.
2. This decision goes effective immediately.
3. An appeal against this decision may be deposited at the Electoral College in the Court of Appeals of Tirana, within 5 days of its announcement.
