OBJECT: To return to complete the multi-name list of candidates for a member of the Tirana Municipal Council, submitted by the Social Democratic Party of Albania, for the elections for the local government bodies of 30 June 2019.

LEGAL REFERENCE : Article 23, point 1, letter "a", of Law no. 10019, dated 29.12.2008 "Code Election of the Republic of Albania, as amended. The Central Election Commission after reviewing the submitted documentation and listening to the discussions of the attendees,

The Central Election Commission after reviewing the documentation submitted by the party "Social Democratic Party "and heard the discussions of representatives of political parties,

NOTES:

The Social Democratic Party of Albania, has been registered as an electoral subject for local government elections of June 30, 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" as amended, the Social Democratic Party of Albania has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, based on Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the municipal council of the Social Democratic Party of Albania and the accompanying documentation submitted and noted the shortcomings of the documentation as follows:

1. Gender quota is not respected in the multi-name list Model 10 K;
2. Declaration for countries by gender quota Model 09 K;

Under these conditions CEC should:

To return the candidature documentation for correction of the deficiencies found by the Social Democratic Party of Albania.

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Returns for completing the documentation for the registration of multi-name list of candidates for members of the Tirana Municipal Council, of the Social Democratic Party of Albania, for the elections for the local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
