FOR RETURN TO COMPLETE THE MULTINAME LIST OF CANDIDATES FOR MEMBERS AT THE MUNICIPAL COUNCIL OF TIRANA, DEPOSITED DEPOSITED BY "NATIONAL UNITY" PARTY FOR ELECTIONS FOR THE LOCAL GOVERNMENTS BODIES OF 30 JUNE 2019

OBJECT: For a return to complete the multi-name list of candidates for members of the Tirana Municipality council, presented by the "National Unity" Party, for elections to local government bodies of 30 June 2019.

LEGAL REFERENCE : Article 23, point 1, letter a, article 67, article 72 and article 73, paragraph 1, of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

Central Election Commission after reviewing the documentation submitted by the Unity Party National ", and heard the discussions of representatives of political parties,

NOTES:

The party of "National Unity" has been registered as an electoral subject for elections to the organs of local government of June 30, 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" as amended, the "National Unity Party" has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, based on Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the Municipal Council of the National Unity Party and the accompanying documentation submitted and noted the deficiencies of the documentation as follows :

1. Identification document and declaration of candidates for members of the municipal council;
2. List of data for candidates for mayor / council member on multi-name lists of political parties, Model 13 K;
3. Forms of self-declaration of candidates for members of the municipal council;

Under these conditions CEC should:

To return the candidacy documentation for correcting the deficiencies found by the Party of "National Unity".

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Returns for completing the documentation for the registration of the multi-name list of candidates for members of the Tirana Municipal Council, of the National Unity Party, for elections to local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals
Tirana, within 5 days of its announcement.
