FOR RETURN TO COMPLETE THE MULTINAME LIST OF CANDIDATES FOR MEMBERS AT THE MUNICIPAL COUNCIL OF DURRES, DEPOSITED DEPOSITED BY THE PARTY "ALLIANCE FOR DEMOCRACY AND SOLIDARITY", FOR ELECTIONS FOR THE LOCAL GOVERNMENTS BODEIS OF 30 JUNE 2019

OBJECT: For return to complete the multiname list of candidates for member at the municipal council of Durres, depozited by "Alliance for Democracy and solidarity". For elections for the local government bodies of 30 june 2019

LEGAL REFERENCE : Article 23, point 1, letter a, article 67, article 72 and article 73, paragraph 1, of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania"

Central Election Commission after reviewing the documentation submitted by the Alliance Party for Democracy and Solidarity ", and heard the discussions of representatives of political parties,

NOTES:

The "Alliance for Democracy and Solidarity" Party has been registered as an electoral subject for elections for local government bodies on 30 June 2019.

Pursuant to Article 67 and Article 72 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" as amended, the "Alliance for Democracy and Solidarity" Party has submitted to CEC documentation for the approval of multi-name lists.

At the meeting of 18.05.2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the multi-name lists of candidates for members of the municipal council of the Party for Democracy and Solidarity and the accompanying documentation submitted and found the deficiencies of the documentation like below:

1. Gender quota is not respected in the multi-name list Model 10 K;
2. Declaration for countries by gender quota Model 09 K;
3. Document identification and declaration of candidates for members of the municipal council.

Under these conditions CEC should:

To return the candidature documentation for correction of the deficiencies found by the "Alliance for Democracy and Solidarity" Party.

FOR THESE REASONS:

The Central Election Commission, based on article 23, point 1, letter a, article 67, points 1, 4, 5 and 6, article 72 and Article 73, point 1 of Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania ", as amended.

DECIDED:

1. Return for completion of the documentation for the registration of the multi-name list of candidates for the members of the Durrës City Council, of the Alliance for Democracy and Solidarity Party, for the elections for the local government bodies of 30 June 2019.
2. This decision shall enter into force immediately.
3. An appeal may be filed against this decision to the Electoral College at the Court of Appeals Tirana, within 5 days of its announcement.
