OBJECT: Adoption of voters' education strategy for local government elections of June 30, 2019

LEGAL REFERENCE: Article 23, item 1, letter "a", article 21, item of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", as amended.
Article 15, item 4 of the law no.96/2017 "On protection of national minorities in the Republic of Albania".

The Central Elections Commission, after reviewing the submitted documentation and hearing the discussions of those present,

NOTES

The Central Election Commission, pursuant to its duties, defined in Article 21, paragraph 9 of the Electoral Code, undertakes and organizes programs on voters education.

During the election period, the Central Election Commission intensifies programs on the education, awareness raising and information of all Albanian voters, in order to raise awareness about the participation in voting, as a fundamental constitutional right and a civic obligation, and the exercise of the right to vote in free and secret way, in compliance with the voting procedures.

CEC, through the strategy for voters education, which is a consolidated institutional practice in every election process, aims to bring the voters closer through programs on the education, information and awareness of voters during the election period.

On adoption of Voters Education Strategy for Local Government Elections of June 30, 2019

The achievement of this goal effectively, within the set timeframe, is a complex process, whose success is interdependent on aligning and good planning of activities that serve to meet these goals and strategic objectives.

The Voters' Education Strategy for June 30, local government elections, outlines the general projects addressed to all voters and the specific projects that target social groups with specific needs, their implementation timeframe and methods and tools that will be applied.

Pursuant to the provisions of Article 15, paragraph 4, of Law No.96 / 2017 "On the Protection of National Minorities in the Republic of Albania", the national minorities will be informed on the electoral process through a special project, which is stipulated in this strategy.

FOR THESE REASONS:

The Central Elections Commission, pursuant to Article 23, item 1, letter "a", article 21, item 9 of the law no. 10019, dated 29.12.2008 "The Electoral Code of the Republic of Albania", as amended, article 15, item 4 of the law no.96/2017 "On protection of national minorities in the Republic of Albania".

DECIDED:

1. To adopt the voters education strategy for local government elections of June 30, 2019, according to the material attached.
2. The Secretary-General, Department of Elections Commissions, Training and Voters Education and the CEC spokesperson will be responsible for following the implementation of this strategy.
3. The content of the TV spots, radio spots, TV subtitles and the media plan for broadcasting them in TV and Radio, will be approved by the CEC.
4. This decision comes immediately into effect.
