Return for completion of the multi-name list of the candidate for the municipality of Durrës, deposited by the National Conservative Party of Albania for the elections to local government bodies of 30.06.2019

In accordance to Article 67 and Article 72 of Law no. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania" as amended, the Conservative National Party of Albania, has submitted to the CEC the documentation for registration as candidate for Mayor Mr. Tomor Qama.
In the meeting of 18.05.2019, pursuant to Article 73 of the Electoral Code, the Central Election Commission verified the documentation of the candidate for Mayor of Durrës, Mr. Tomor Qama and the attached documentation and found lack of the documentation as follows:

1. Declaration of the candidate declaring that he enjoys the right and will to run for mayor in the Municipality of Durrës, proposed by the National Conservative Party of Albania in the elections for the local government bodies of 30.06.2019;
2. Copy of the ID card of Mr. Tomor Qama where it results that Mr. Tomor Qama is a resident in the Municipality of Durrës;
3. CV of Mr. Tomor Qama as a candidate for mayor of the municipality of Durrës;
4. The Self-Declaration Form, in accordance to Law no. 138/2015 "On guaranteeing the integrity of persons elected, appointed or exercising public functions".

Under these conditions the CEC must:

Return the candidature documentation for correction of the deficiencies stated by the candidate for mayor.

FOR THE ABOVE REASONS:

The Central Election Commission based on Article 23, point 1, letter "a", article 67, points 1, 4, 5 and 6, article 72 and article 73, point 1 of law nr. 10019 dated 29.12.2008 "The Electoral Code of the Republic of Albania", amended

DECIDED:

1. Return for completion the documentation for registration of the candidate for mayor of Durrës, Mr. Tomor Qama, for the elections to local government bodies of 30 June 2019.
2. This decision goes effective immediately.
3. Against this decision a complaint can be filed at the Electoral College at the Tirana Court of Appeal within 5 days of its announcement.
