**PLAINTIFF** Democratic Belief Party

**OBJECT:** On announcing the invalidity of elections in Fieri Municipality

**LEGAL REFERENCE:** Article 23, item 1, letter "a", article 129, item 1, 3, letter (a) and article 126, item 2 of the Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", as amended.

The Central Elections Commission, after reviewing the submitted documentation and hearing the discussions of representatives of political parties,

**NOTES**

Democratic Belief electoral subject filed with the CEC a complaint which is in compliance with the criteria provided for in article 127 of the Electoral Code and is registered in the Register of Election Complaints, as complaint no.48, date 05.07.2019.



In its meeting on July 6, 2019, at 11.00 hrs, after the report of Mr. Klement Zguri and the discussions of the representatives of political parties, it was found that this complaint did not meet the criteria of the form, thus not meeting one of the requirements of article 126, item 2 of the Electoral Code.

For this reason, the Central Elections Commission, in its decision no.986, dated 06.07.2019, decided to send back the complaint no. 49, filed with the CEC on 05.07.2019, pursuant to article 129, item 3, "c" of the Electoral Code , in order to be completed.

Article 129, item 4 of the Electoral Code provides that the complainant should complete the complaint and file it to the CEC within 24 hours from the decision. The complainant, Democratic Belief Party filed the completed complaint to the CEC, within the deadline and based on the requirements of the CEC decision.

In its meeting in July 9, 2019, at 10.00 hrs, after the report of Mr. Klement Zguri, the documentation of the complaint was checked and it was found to be in compliance with the requirements of article 129, item 4 of the Electoral Code.

Therefore, the complaint meets the criteria of the form, provided in article 126 and the criteria defined in article 130. Based on article 129, item 3, letter a of the law no.1009, dated 29.12.2008, "The Electoral Code of the Republic of Albania", as amended and the CEC should pass the complaint for review.

#### **FOR THESE REASONS:**

The Central Elections Commission, based on article 21, item 1, article 126, item 2, article 129, item 1, 3, letter 'a' of the law no.10019 dated 29.12.2009 "The Electoral Code of the Republic of Albania", as amended

#### **DECIDED:**

1. To pass for review the complaint no. 48, dated 05.07.2019, filed by the electoral subject Democratic Belief Party.
2. The review will take place on 11.07.2019, at 10.20 hrs.
3. This decision comes immediately into force.
4. An appeal may be filed against the decision in the Electoral College, Tirana Court of Appeals, within five days from its publication.
