SHKODER REGION, FOR LOCAL GOVERNMENT ELECTIONS OF JUNE 30, 2019**

Reviewed the issue with the following

OBJECT: On the release of the elections result for the election of Shkoder Mayor, Shkoder Region, for local government elections of June 30, 2019

LEGAL REFERENCE: Article 21, point 7, article 23, letter "a", article 123, article 166, item 1 of the Law No. 10019, dated 29.12.2008 "Electoral Code of the Republic of Albania", as amended.

The Central Elections Commission, after reviewing the submitted documentation and hearing the discussions of representatives of political parties,

NOTES

The territory of Shkoder Municipality election zone is divided into 4 EAZs. The CEC verifies and issues the result for the election zone, based on the tabulation of results issued by each CEAZ in the respective election zone.

At the end of the process of delivery of the Aggregate Tables of Results and Tables of Result for each voting center for Shkoder Mayor from the 4 CEAZs of this municipality, the CEC issues the result for this election zone, following the procedures provided for in Article 123 of the Code.



I. Before completing the Aggregate Table of the Results for the election of Shkoder Mayor, the Tables of Results for the candidates for mayor in the voting centers of these CEAZs, completed by the Counting Teams, were compared with the Aggregate Tables of Results adopted by CEAZ no.02, CEAZ no.03, CEAZ no.04, CEAZ no.05, and their result entered into the electronic system and the result was as follows:

- The Aggregate Table of Results adopted by CEAZ no.2 does not include the result of the Voting Centers no.077, VC no.00771, VC no.00791, VC no.0082, VC no.0083, VC no.0086, VC no.00861, VC no.0224, VC no.0345.

-The Aggregate Tables of Results adopted by the CEAZ no.03, CEAZ no.04, CEAZ no.05, include the results of all the tabulation of results of VCs in these CEAZs.

- By comparing the tabulation of results for each voting center with the aggregate tables of results of the respective EAZ and their result entered in the electronic system, the following discrepancies in the figures were observed:

The CEC, through a decision, will adopt the Aggregate Table of Results for the election of Shkoder Mayor, Shkoder Region, with the corrected figures, based on the tabulation of results issued by each CEAZ in the election zone and original tabulation of results of each VC of this Municipality, as completed by the counting team, except for VC no. 0077, VC no.00771, VC no.00791, VC no.0082, VC no.0083, VC no.0086, VC no.00861, VC no.0224, VC no.0345 and announce the winning candidate for Mayor of Shkoder, Shkoder Municipality.

FOR THESE REASONS:

The Central Elections Commission, based on article 21, item 7, article 23, item 1, letter "a" and article 123 and 166 of the law no.10019 dated 29.12.2009 "The Electoral Code of the Republic of Albania", as amended

DECIDED:

1. To adopt the Aggregate Table of Results the election of Shkoder Mayor, Shkoder Region, attached to this decision.
2. To announce as winner of Shkoder Municipality Mr. Valdrin Luigj Pjetri, proposed by the Alliance for European Albania.
3. This decision enters immediately into force.
4. An appeal may be filed against the decision in the Electoral College, Tirana Court of Appeals.
